Late fee, if after August 1st \$25.00. We will not guarantee your space after August 1 st if we have not heard from you.	
Total cost is due when the application is accepted, or you can mail it with the application and it will be returned if the application is not accepted. Without full payment you are not guaranteed a space.	

VENDOR PERMIT Artists also need to get a vendor permit from Doña Ana County. A copy is available on the website at https://www.donaanacounty.org/sites/default/files/pages/Vendor_App_7-2017.pdf from HCRC, or from the County Clerk Office . As far as we know this permit costs \$5.00 per day (\$10.00 for Festival), or \$35.00 per year. This is your responsibility, and we hear that some people at a different festival had to pay fines.

SILENT AUCTION: A silent auction is made possible by artists' donations to the Holy Cross Retreat Center, and income from the auction helps support the activities of the Retreat Center. As part of the entry fee each artist is expected to contribute an item that is representative of your **BEST WORK**—an item of average or higher value, at least \$25.00. To enable us to best display this work, please bring your donation during the month of August or have it available when you check in on Friday, August 30th. Vendors who do so will receive an invitation to a reception for artists on Friday evening, and rolls and beverages each morning during the festival. We appreciate your cooperation. Thank you.
